Ag teacht le hAit 182c den Acht Pleanála agus Forbartha, 2000, mar a leasaíodh ag an Acht Pleanála agus Forbartha (Infraestrucrúr Straiteiseach, 2006), rinne SHELL E&P IRELAND LIMITED ("SEPIL") (ar son SEPIL, Statoil Exploration (Ireland) Limited agus Vermilion Energy Ireland Limited) iarratas ar An mBord Pleanála ar an 12ú Feabhra 2009, maidir le tóigil Piobán Intíre na Coiribe, atá ar na bacáin, i gCo Mhaigh Eo, ag cur san áireamh infreastruachtaí straitéiseach uas-sruadhach gáis. Síneann an píblíne atchóiriúthe ón bpointe barr taoide go dtí an bpointe ar an talún ag Gleann an Ghad, i gCo. Mhaigh Eo, ar bhealach faoi Bhá Sruthmadanagcon go dtí baile fearainn Na hEachú agus go dtí baile fearainn Beal an Ghoile Theas, agus isteach sa Chriochphort Gáis i mBéal an Atha Bhui. Ar an 31ú Bealtaine 2010, de bhun fógra a d'éisigh An Bord Pleanála faoi Alt 182c(5) den Acht Pleanála agus Forbartha 2000, mar a leasaíodh, cuireadh athraithe sonraithe, breis eolais agus Ráiteas (leasaithe) Tionchair Timpeallachta faoi bhráid An Bord Pleanála. Is féidir na hathraithe sonraithe, an bheiris eolais agus an Ráiteas (leasaithe) Tionchair Timpeallachta a scrúdú saor in aisce nó a cheannach ar tháille sonraithe i rith uireanta poiblí oscailte ar feadh tréimhse ceithre (4) seachtaine ag tosú ar an gCéadaoin, 23ú Meitheamh 2010 ag na láithreacha seo:

- Na hOfiúgí, An Bord Pleanála, 64 Sráid Mharpilbhride, Baile Átha Cliath 1
- Na hOfiúgí, Comhairle Chontae Mhaigh Eo, Aras an Chontae, Caisleán an Bharraigh, Contae Mhaigh Eo
- Na hOfiúgí, Comhairle Chontae Mhaigh Eo, Bóthar na hEaglaise, Béal a' Muirthead, Contae Mhaigh Eo
- An Ofiúg Aitiúil SEPIL, 4 Udarás na Gaeltachta, Béal a' Muirthead, Contae Mhaigh Eo.

1. Tá dreach na hathraithe sonraithe le feiceáil thíos (tá na logainmneacha go léir a luitéar suite i gContae Mhaigh Eo ach amhain Bá Sruthmadanagcon a bhfuil cuid de sa chládach).

- Tá bealach athraithe an phíblíne le bheith faoi Bhá Sruthmadanagcon (agus inrianta chuijge) idir slabhraoicht 83+910 agus 89+550 (mar a bhí na slabhraoictaí píblíne i 2009) (Gleann an Ghad agus Na hEachú);
- Méadú suntasach níos mó ar an fhad eatarthu a scarann óna chéile an píblíne molta agus an teach cónaithe is goire a bhfuil daoine ina gcónai ann;
- Tá fad an phíblíne gearrtha go 8.3km, íslíu de 0.9km;
- 'Séard atá i gceist ná an píblíne a shocrú i dtollán, a bhfuil trastomhas seachtrach 4.2m aige, ó Na hEachú go Gleann an Ghad ar an mbealach athraithe faoi Bhá Sruthmadanagcon (agus na hriantáin chuijge) ar feadh 4.9km;
- Beidh tuairim is 4.6 km den tollán faoi Bhá Sruthmadanagcon;
- 'Sé an tUasbhrú Oibriúcháin Ceadaithe (MAOP) sa Phíblíne Intíre (idir Comhla Suite Intíre (LVI) agus an críochphort ag Droichead Bhéal an Atha Búi) ná 100 barg;
- 'Sé an tUasbhrú Oibriúcháin Ceadaithe (MAOP) den phíobán thar chládach amach (uas-sruadhach de agus ag áireamh an LVI) ná 150 barg;
- Nil an píblíne suite níos mó taobh istigh den Áitreibh le Tosaíocht I gCoimhléas Phortach Gleann na mBuaidhe (cSAC);
- Tóigfar an tollán i dtreo amhain ó Na hEachú agus cuirfear an píblíne le chéile sula leigfeár é sa tollán ó Na hEachú; mar thoradh air sin beidh an clós tolláinaithe ag Na hEachú níos mó agus feictear i bhfud níos mó gniomhaiochtá ann seachas ag an gclós tolláinaithe ag Gleann an Ghad agus ní bheidh aon ghníomhaiocht tóigala ag Ros Dumhach;
- Tá an roinnt sin den Phíblíne ó shlabhraoicht 83+400 go dtí an pointe barr taoide áiriúthe san iarratas forbartha.

Airítear freisin na hathraithe leantacha don fhorbairt atá ag eascairte as na hathraithe sonraithe. Ina measc tá: imleacán breise, cábá breise, cábá snáthoptaic, piobán taoscáithe uisce laistigh den tollán, méadú ar leithéid an bhóthair cloiche le 3m go 12m, iompar ábhar go clós tolláinaithe Na hEachú, toirt mhéadaithe den ábhar fochealte (c.68,000 m ciúbaithe) agus téarma níos faide do na hoibreacha tógála.

2. Cuireadh breis eolais ar fáil don Bhord. Is féidir achoimre den bheiris eolais sin a áireamh faoi na teidil seo:

- Ráiteas (leasaithe) Tionchair Timpeallachta (EIS) ag áireamh na modheolaiochtá tóigala leasaithe agus ag atchóiriú bhealach an phíblíne agus na tionchair a éirionn as;
- Cuireann Agusín Q den Ráiteas Tionchair Timpeallachta cnuasach comhtháite cárípeisi dearthaithe ar fail, a léiríonn go soiléir fianaise iomlán trídhearcach sásúil nach bhfuil baol doghlactha ar bith dón phobal;
- Ráiteas Tionchair Natura ag tacú le an Measúnú Córí an tionscnaimh athraithe;
- Sonrai faoi thóigáil an phíblíne agus úrlísi le seasmhacht an phortaigh a chosaint; agus
- Línócht leasaithe a thaispeánnann go mion réimse iomlán an phíblíne.

Tá ordú éigeantach seilbhe nuá curtha faoi bhráid An Bord Pleanála, chun na hathchóiriúthe/mionathraithe ainmnithe seo a chur san áireamh. Tá an ordú éigeantach seilbhe se le fail le haghaidh iniúchadh ag na háiteanna atá ainmnithe thus agus ag Stáisiún na nGardaí, Béal an Muirthead, Co. Mhaigh Eo.

**NOTICE OF SPECIFIED ALTERATIONS TO THE PIPELINE ROUTE
AND FURTHER INFORMATION SUBMITTED IN RELATION TO A
DIRECT PLANNING APPLICATION TO AN BORD PLEANALA IN
RESPECT OF THE CORRIB ONSHORE GAS PIPELINE,
A STRATEGIC INFRASTRUCTURE DEVELOPMENT**

In accordance with Section 182C of the Planning and Development Act, 2000 as amended by the Planning and Development (Strategic Infrastructure) Act, 2006, SHELL E & P IRELAND LIMITED ("SEPIL") (on behalf of SEPIL, Statoil Exploration (Ireland) Limited and Vermilion Energy Ireland Limited) made an application to An Bord Pleanála on the 12th February, 2009 in relation to the proposed construction of the Corrib Onshore Pipeline, Co. Mayo, comprising strategic upstream gas pipeline infrastructure. The altered pipeline extends from the High Water Mark to the landfall at Glengad townland County Mayo in a route under Sruwaddacon Bay to Aghoos townland and to Bellaghey South townland, and into the Bellanaboy Bridge Gas Terminal. Alterations, further information and a revised Environmental Impact Statement (EIS) were lodged with An Bord Pleanála on the 31st May, 2010 on foot of a notice and request for specified alterations issued by the Board on 2nd November, 2009 under Section 182C(5) of the Planning and Development Act, 2000, as amended. These specified alterations and further information together with the original planning application documentation including the revised EIS, may be inspected free of charge or purchased on payment of a specified fee during public opening hours for a period of 4 weeks commencing on Wednesday 30th June, 2010 at the following locations:

- The Offices of An Bord Pleanála, 64 Marlborough Street, Dublin 1
- The Offices of Mayo County Council, Aras an Chontae, Castlebar, Co. Mayo
- The Offices of Mayo County Council, Church Road, Belmullet, Co. Mayo
- SEPIL Local Office, 4 Udarás Na Gaeltachta, Belmullet, Co. Mayo

Full details of the alterations are also provided within the revised EIS and the book of Further Information drawings.

1. The nature of the specified alterations is indicated below (All placenames referred to are located in County Mayo save for Sruwaddacon Bay which is partly in County Mayo and partly in the foreshore):

- Modified pipeline route, to be beneath Sruwaddacon Bay (and approaches to same) between chainages 83+910 and 89+550 (per pipeline chainages in 2009 application) (Glengad and Aghoos).
- A further significant increase in separation distance between the proposed pipeline to the nearest occupied residence.
- The proposed pipeline is now reduced in length by 0.9 km to approximately 8.3km long.
- The altered route under Sruwaddacon Bay, (and the approaches to same) of approximately 4.9km will include the placing of the pipeline within a 4.2m (outside diameter) tunnel, constructed from Aghoos to Glengad.
- Approximately 4.6km of the tunnel will be beneath Sruwaddacon Bay.
- A Maximum Allowable Operating Pressure (MAOP) in the Onshore Pipeline (between the Landfall Valve Installation (LVI) and the Bellanaboy Bridge Gas Terminal) of 100 barg.
- An MAOP in the Offshore Pipeline (upstream of, and including, the LVI) of 150 barg.
- The proposed pipeline is no longer located within Priority Habitat in the Glenamoy Bog Complex (cSAC).
- The tunnel will be constructed in one direction from Aghoos and the pipeline will be assembled and installed into the tunnel from Aghoos; as a result the tunnelling compound at Aghoos will be larger and will see an increased volume of activity while the tunnelling compound at Glengad will see a decreased level of activity, and there will be no construction activity at Rossport.
- The section of pipeline from chainage 83+400 to the High Water Mark at Glengad has been included within the development application.

Ancillary changes to the development arising out of the specified alterations are also included. These include: a spare umbilical, electrical cable, fibre optic cable and water discharge pipeline within the tunnel, increased width of the stone road by 3m to 12m, increased importation of material to the Aghoos tunnelling compound, increased volume of excavated material (approximately 68,000m³) and a longer duration of construction works.

2. Further Information has been furnished to The Board. The further information can be summarised under the following topics:

- A revised EIS detailing the revised construction methodology and pipeline route alignment and resulting impacts;
- Appendix Q of the revised EIS provides an integrated set of design documentation which presents a complete, transparent and adequate demonstration that the pipeline does not pose an unacceptable risk to the public;
- A Natura Impact Statement to support the Appropriate Assessment of the altered scheme;
- Details of construction of the pipeline in peat and measures to mitigate peat instability; and
- Revised drawings which fully describe the full extent of the proposed onshore pipeline.

A new compulsory acquisition order has been submitted to An Bord Pleanála to incorporate the specified alterations/modifications. This compulsory acquisition order is available for inspection at the locations specified above and also at Belmullet Garda Station, Belmullet, Co Mayo.

Submissions or observations in relation to the **SPECIFIED ALTERATIONS AND FURTHER INFORMATION ONLY** may be made solely to An Bord Pleanála (The Board), 64 Marlborough Street, Dublin 1 during the above-mentioned four weeks.

Any submissions/observations must be accompanied by a fee of €50 (except for certain prescribed bodies). There is no fee required to make a submission in relation to those parties/individuals who have already made a valid written submission to the Board regarding the application.

Submissions or observations must be received by the Board not later than Wednesday 28th July, 2010. Such submissions/observations must also include the following information:

- (i.) The name of the person making the submission or observation, the name of the person acting on his or her behalf, if any, and the address to which any correspondence relating to the specified alterations and further information should be sent.
- (ii.) The subject matter of the submission or observation; and
- (iii.) The reasons, considerations and arguments on which the submission or observation is based in full.

Any submissions or observations which do not comply with the above requirements cannot be considered by the Board.
